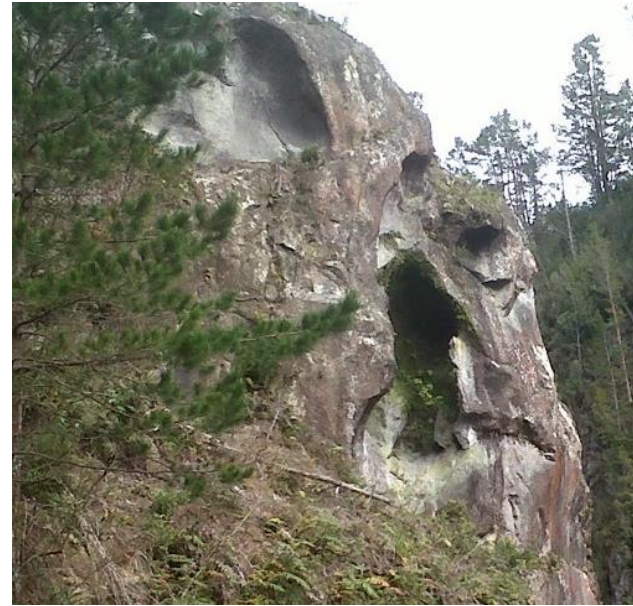

What is it and what will it do?

The Tapuika Environmental Management Plan is a strategic planning document that enables Tapuika to voice – in relation to the natural environment:

- What we value
- What concerns us
- What outcomes we would like to see

It will:

- be our collective statement of issues, aspirations and projects over the next five years
- guide Tapuika-led environmental projects
- enable more effective participation in Resource Management Act processes
- ensure that we are proactive, instead of reactive
- outline how we expect Councils, consultants and resource consent applicants to consult with us

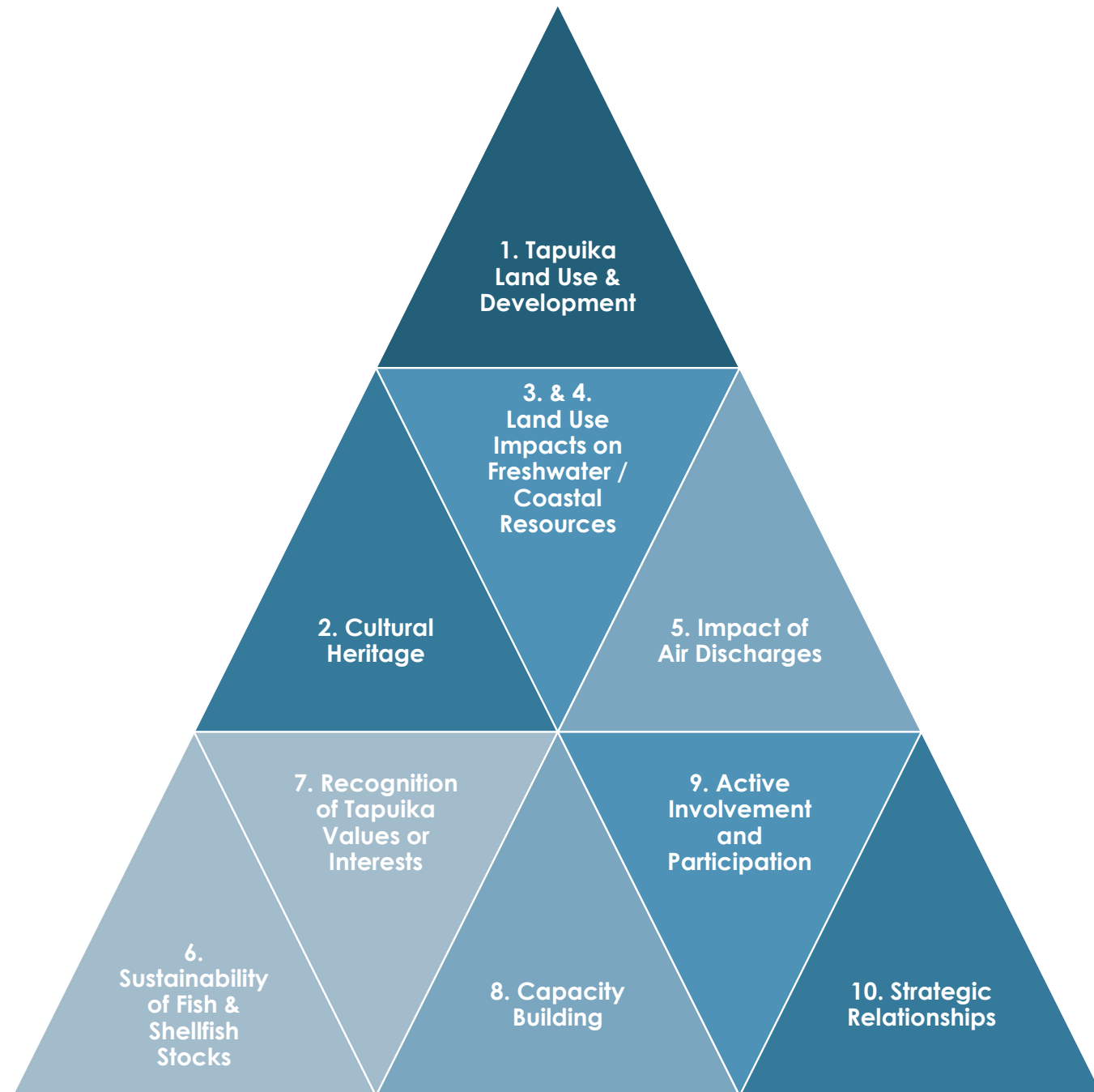
