Matai Pacific - Post Harvest Cadetship Programme

- This Expression of Interest form has been developed to align with the Matai Pacific Cadetship Programme kaupapa and the career opportunities provided by our Post Harvest partners. The EOI enables candidates to be considered for cadetship opportunities and, where appropriate, other non-cadetship employment opportunities within post-harvest facilities.

Programme Overview

- Matai Pacific, in partnership with participating iwi and post-harvest providers, are offering a total of six cadetships as part of the 2026 Post-Harvest Cadetship Programme.
 - These cadetships will be shared across three post-harvest partners.
 - Final cadetship allocations and placements will be confirmed by the post-harvest interview panels, following the interview and selection process.
 - Cadetships are designed to provide structured on-the-job learning, industry exposure, and long-term career pathway development within the post-harvest sector.

Additional Employment Opportunities (Outside the Cadetship Programme)

- In addition to the cadetship programme, Matai Pacific may also recommend candidates for other employment opportunities within post-harvest facilities where there is a strong alignment between a candidate's skills, experience, or interests and packhouse operational needs.

Examples may include (but are not limited to):

- Seasonal packhouse roles
- Forklift operators (where a current licence is held)
- Quality Controllers (QC)
- Other specialist or operational roles identified by the post-harvest facility or Matai Pacific

Important Clarification:

- These roles are not part of the cadetship programme.
- Any employment offered outside the cadetship programme will be directly between the candidate and the post-harvest employer.
