### 2. Environmental Forum cancellation for September | Next month's kaupapa



The upcoming Tapuika Environmental Forum this weekend is cancelled due to bad weather affecting the planned haerenga. Consequently we will meet next month, Sunday 9th October 10am at the Tapuika Iwi Office. BOP Regional Council will be coming to discuss their work on the Kaituna. They are keen to korero with whānau to ensure the work they undertake doesn't affect the places our whānau swim at during summer. They are also keen to assist with any access issues whānau have to their swimming holes. Nau mai, haere mai.



#### 3. Kaharoa Pest Control – Tapuika Kaitiaki Volunteers

Over the past few months at the Tapuika Environmental Forums we have been sharing korero about our Tapuika connection to the Kaharoa-Mangorewa area of our tribal boundaries and the kaitiakitanga mahi that we are involved in for the ngāhere including the manu.

One of the manu that we are lucky to still have up in that ngāhere is the kōkako. These kōkako are a relic population which means they have been up there since way back and our tūpuna would have heard the same reo in those days.

These manu are a very vulnerable species and need protection if we want our mokopuna to experience the tangi and reo of these Kaharoa kōkako. The breeding season is nearly upon us and some of

us have been going up to do our bit to get rid of the biggest predators of the kōkako – rats, possums, and stoats.

#### 5. Te Puke Wastewater Treatment Plant Site Visit

Tapuika is invited to a tour of the new AquaCuro Bio-Remediation project at the Te Puke Wastewater Treatment Plant on Sunday 18 September (time TBC) to see how they are using algae sourced from our awa to take nitrogen and phosphorous out of the water. A kapu tī will follow at Rangiuru Business Park for a presentation of where the main waste pipe will go. Whānau are encouraged to bring any questions you may have.

A report has been received from the bone specialists regarding the kōiwi found at Pukaingataru /Rangiuru Business Park site but we are awaiting the results of the radio-carbon dating. Once this has been completed the Archaeologist will then be able able to present the findings to interested whānau. Hui date to be advised.



## 8. AFFCO Rangiuru Resource consent decision

We have been advised that the decision for the Affco Rangiuru consent will be available on Monday 3 October. Thank you to those whānau who submitted through the consent process. We will advise you of the outcome of the Commissioner hearing when this comes in.

#### 9. Te Karaka Pā site visit

The Te Karaka Pā site was sold back in July and the new owner has invited interested iwi to visit the whenua to discuss his plans for the block on Monday 10th October. This is a significant site particularly for Ngāti Moko and Tapuika. It was a pā kainga, battle site and urupā.
